Rex Engle – have restrooms been addressed? John Mazze – yes.

John Mazze – Yes. Clark & Post does send documents to Builders Exchange and others that go out to construction folks. He does believe that this is where the two bidders got the information. Went out to half a dozen local contractors that have bid these projects in the past and wanted to make sure they saw the ad. We only got two but they are good bids.

Bob Kamnikar – Do you find that some contractors are not looking because they are busy? Some felt that they could not compete, shied away from it.

John Mazze – They shy away because they usually are going for bigger jobs. Some bidders like the smaller pool, it gives them a chance.

Rex Engle – indicated that we make sure that we did advertise and that the architect reached out to local contractors and such.

Marc Zappa - if the project is not done by August 5, 2016, what type of penalties are in effect.

John Mazze – there is none. They have done a better job getting jobs completed by having all the materials sitting there waiting. We are proactive from that perspective. Cannot guarantee anything with or without a penalty clause. We will have everything in place before the project start.

Bob Kamnikar - Do you have anything set up or in place, for example; change orders?

John Mazze – No, check with suppliers on materials and making sure the materials are available or will be by date.

Bob Kamnikar - Thank you John, I appreciate it.
